NOTICE FOR PRE-QUALIFICATION
OF
CONTRACTORS FOR MAINTENANCE WORKS
FOR F.Y. 2008-09

National Highway Authority (NHA) invites applications from well reputed and experienced contractors who are already pre-qualified with various Government Departments for Enlistment / Pre-qualification with NHA for F.Y. 2008-09 for the following categories of works:

- a. Routine Maintenance
- b. Emergency Maintenance
- c. Highway Safety
- d. Geometric Improvement
- e. Periodic Maintenance (Functional)
- f. Periodic Maintenance (Structural)
- g. Rehabilitation

2. All interested contractors are required to submit the following mandatory details and provide documentary evidence for their technical / financial capabilities with relevant experience in similar fields in two (2) sets separately for each of the above category to enlistment purposes:

- a. **Establishment / Registration Firm:**
 - Evidence of valid registration with Pakistan Engineering Council (PEC) confirming the category proprietorship engineers working with the company.
 - Evidence of valid registration with Provincial Highway Authority / Department C & W etc.
- b. **Financial Capacity:**
 - Financial statement for at least 3 years and latest Auditors Report.
 - Certificate for the banks(s) showing confirmed line of credit along with bank reference.
 - Certificate from Income Tax Department
- c. **Work Experience with NHA Other Departments:**
 - Approximate value of work(s) in hand supported with documentary evidence.
 - Date of Contracts completed within due date without any time extension (relevant detail to be provided)
 - Documents pertaining to contracts performance in previous works to be endorsed or any special wards given

- d. **Human Resource:**
 - List of permanent / temporary technical and non-technical employees by the Company with resumes.
- e. **Plant & Machinery**
 - List of complete machinery equipment vehicles etc owned by company, evidence of ownership.
- f. **Litigation**
 - Number of court cases with various Govt. Departments under process to be quoted along with brief summary of each case.


3. The Questionnaire for enlistment may be purchased from the office of Director (Maintenance), National Highway Authority by depositing of fees Rs. 1,000/- each in the shape of Pay Order / Demand Draft in favour of General Manager (Balochistan) National Highway Authority, Quetta (non-refundable) w.e.f. date of appearance of advertisement in press upto **20th March, 2008.**

4. All interested firms shall submit fresh applications in 2 sets as consideration, shall not be given any application submitted previously. It is further clarified THAT earlier pre-qualification / enlistment shall not be considered in NHA future bidding competition, if the contractor does not file a fresh application within the scheduled period.

5. Firms interested in pre-qualification may submit the above information duly supported by requisite documents to Director (Maintenance) NHA, Quetta latest by **28th March, 2008.**

6. Applicants will be required to submit undertaking on judicial paper confirming that information given by them are correct. In case of false statement or incorrect information applicant will be liable for black listing along with legal action by NHA.
